Introduction

This has been an exciting year for the PPG at Eagle House Surgery as we have moved from being a virtual group into a real one

By March 2014, the virtual group numbers totalled 46 and the real PPG numbers totalled 8, the practice aspires to increase these numbers in the next year to reach between 2 and 5% of the practice population (currently standing at 8,400)

The group started meeting in November 2013 and has met monthly as they are establishing themselves. Achievements include:

- Agreeing terms of reference and roles for chairperson and secretary
- Contributing a to a review of the culture and values that underpin Eagle House (EHS)
- Reviewing the content and advising on developments of EHS website
- Representing EHS at the North Dorset Health Network meeting
- Participating in the North Dorset PPG network and chairperson meetings
- Contributing to the DT11 forum that is planning a local community Health & Well Being event that will include support and activities from the PPG
- Networking with Whitecliff Mill Street PPG at locality meetings with a view to developing closer working relations

Plans for the next 12 months include:

- Increasing group membership and reviewing membership against practice demographics to ensure that the group is representative of the practice population
- Contributing to the design of the practice survey to be undertaken Summer 2014, and participate in decision making process to agree priorities from the results
- Identifying opportunities to actively engage with the practice population to undertake health promotion activities as well as developing a better understanding of priority issues
- Develop active relationships with more members of practice staff to consolidate the role of the PPG within the structures of EHS
- Continue to participate in local networking opportunities and actively contribute to health promotion activities in the town and surrounding area
